1. WHERE IS ELPIS GARDEN PHASE 3?

A. ELPIS GARDEN PHASE 3 is an undeveloped parcel of land in ODE-OMI, IBEJU LEKKI, LAGOS STATE.

2. WHO ARE THE OWNERS/DEVELOPERS OF ELPIS GARDEN PHASE 3?
